- **Mayor/Council/Attorney/Manager/Clerk Comments:**
 - Councilmember Troup stated the Cone with a Cop was very well put on.
 - Mayor Dudley echoed this sentiment and mentioned that an article on the Kenneth City initiative was published in the Messenger.
 - Attorney Mora stated he just lectured at the Institute for Elected Municipal Officials (IEMO) and he encouraged the members who have not attended to attend. It is a tremendous resource for meeting your peers and learning the basics and skills that help you be better elected officials. The next session will be in October in Tampa.
 - Attorney Mora will be lecturing next month on the legal issues surrounding ADA accessibility of websites and documents for local governments.
 - Manager Campbell stated the old traffic signal that existed at the corner of Joe's Creek and 58th street has been removed. It is being replaced with a Rapid Feedback Beacon (RFB) Crosswalk. This will enable the residents to cross over 58th Street. The crosswalks do not properly align; thus, they need to reassess the proper way to install this. It should be complete in 2-3 months.
