Pinellas County Fertilizer Use & Landscape Maintenance Ordinance





How to keep your yard looking great, save some money and keep our waters fun!



Guide to the Pinellas County Fertilizer Ordinance

Pinellas County Ordinance, Article XIII, Chapter 58, regulates landscape maintenance practices and the sale and use of fertilizers containing nitrogen or phosphorus to protect Pinellas County's aquatic environment.

Homeowners, landscapers and lawn care services must protect our aquatic environment by following the practices described in the ordinance.

Violators of the fertilizer ordinance may be fined up to \$10,000 per day.

Keep Algae-feeding Nutrients Out of Our Waterways. How You Can Be Floridian.

Pinellas County law bans the sale and use of any lawn or landscape fertilizer with NITROGEN or PHOSPHOROUS from June 1 to September 30.

During the summer, use Florida-friendly yard products that contain iron and other micronutrients. Visit <u>www.BeFloridian.org</u> for more landscaping tips.

Reclaimed water can contain high amounts of nutrients therefore fertilizers may not be needed. Visit the reclaimed water areas map on www.pinellascounty.org/fertilizer.

Limit application to no more than 4 pounds of nitrogen per 1000 square feet per YEAR.

Do not overwater and make sure sprinklers are adjusted to avoid hitting the road or driveway.

Avoid using phosphorous! Only use phosphorous if a soil test says its needed.

Protect the water! Keep fertilizer at least 10 feet away from any seawall or body of water.



Ask for credentials!

All fertilizer applicators must display a Pinellas County vehicle decal. All landscape maintenance staff must display a Pinellas County vehicle decal.
